ABOUT US

The National Festival of Making is a unique celebration of UK making, from the kitchen table to the factory floor. Presenting a programme of work that combines Art, Manufacturing, Making and Communities - commissioning international and national artists to create original works and participatory festival events that engage local audiences and increase culture seeking visitors.

Launched in 2017 after a period of Research & Development and partnership building, the Festival has become embedded in Blackburn's cultural community whilst attracting national artists, audiences and significant media profiles. Approximately 40,000 visitors have attended the festival each year, to take part in 100's of making activities and experience 25+ original artistic commissions with artists and manufacturers as part of the Festival's headline commissioning programme, Art in Manufacturing.

The festival is built on collaboration and partnerships and aims to create a diverse and multigenerational festival experience embedded deeply into the community. We use 'Making' to highlight its positive effects on community cohesion, health & wellbeing and employability.



NATIONAL FESTIVAL OF MAKING 2020 / 2021

Due to the COVID-19 pandemic, 2020's Festival was cancelled with an alternative programme of works created for the year that meet many of the Festival aims and agendas. The fourth Festival will take place in June 2021 with a series of original commissions, long term community engagement initiatives and a programme of making.

These are voluntary positions with travel and expenses to board meetings refundable. Board meetings are quarterly and diarised at a suitable time for all members. Meetings are held in the North West, generally in Blackburn, Lancaster or online. Additionally we aim to have one facilitated Board Away Day each year.

Between meetings, we encourage Board Members to attend the wider Stakeholder Meetings where possible. It is also important that Board Members attend and support the June 2021 festival and other ad hoc events throughout the year.

Appointments are for an initial term of one year, extended to three years by mutual agreement, with the option of an additional three years (this is with the exception of the founding members).
